Membership Agreement with the Western Soarers Club

1. I am aware that hang gliding and paragliding can be dangerous and that being carried in a hang glider or paraglider involves a risk of serious injury and even death. I acknowledge that any fee which I may be paying does not include any amount for liability insurance to cover the Western Soarers, its servants, agents, instructors, pilots, independent contractors, or owners. I acknowledge that I will be engaging in hang gliding or paragliding activity and/or as a passenger in a hang glider or paraglider entirely and absolutely at my own risk. I further agree that I will not make any claim against the Western Soarers or their servants, agents, instructors, pilots or independent subcontractors or owners, for or in respect of any loss or injury (whether fatal or otherwise) to myself or to my property, however caused, and whether or not caused by the negligence of any person or the failure of any equipment during hang gliding or paragliding activity. I acknowledge that the Western Soarers is entering into this Agreement as trustee and agent for their servants, agents, instructors, pilots and independent sub-contractors and owners.
2. It is not intended by this agreement to exclude or modify in any way liabilities of the Western Soarers which cannot by law be excluded or modified. All other express warranties are hereby expressly excluded.
3. I hereby agree to indemnify the Western Soarers, its servants, agents, instructors, pilots and each of them against any claim which may be made against them by any person arising out of any act or default on my part during any such activity.
4. The term "owners" where used in this agreement includes the owners and occupiers of property where takeoff, flying and landing of hang gliders or paragliders may take place.
